Minutes of the Annual Congregation Financial Meeting January 27, 2013

Pastor Holmer gave the opening prayer.

Detlef Koska, Church Council President, called the meeting to order at 10:55 a.m.

The tellers reported the presence of a quorum.

The agenda was unanimously approved as presented.

The minutes of the June 3, 2012 Governance meeting were approved as presented.

Peter Clemens, Church Council Vice President, noted that 2012 had ended on a positive note with the budget coming in within 1% of the predicted. Neither contingency nor reserve funds were used. He also reported that the mortgage had been refinanced with Lake Forest Bank and Trust, lowering the interest rate from 6% to 4.5%, incurring no loan origination fee, and maintaining the line of credit that we have never needed to use.

Mike Bennett, Congregation Treasurer, presented the proposed 2013 budget. He noted that the details of the budget were in the report. He made note of the following:

- Member contributions were down about \$7000.
- A transfer of \$5000 will be made from the contingency fund to the general fund to pay for a new part time staff position, Volunteer Coordinator, beginning August 1, 2013.
- There is an \$11,000 increase in personnel expenses.
 - * The 2% reduction in Social Security tax was not renewed this year.
 - All staff members were given a 2% raise.
 - * The new Volunteer Coordinator position funded for the last 5 months of 2013.
- The actual property expenditures in 2012 were \$73,180, which included a number of major repairs. The 2013 property budget returns to the level of prior years minus the \$10,000 set aside for the major maintenance account. As the report notes, if the \$10,000 is available at the end of the year, it will be moved to that account.

Comments/questions:

- Carol Bennett noted the following concerns
 - Prepaid contributions appear to be down \$40,000 from last year
 - * She feels that the yearly reserve of \$10,000 for major maintenance is an important practice to continue.
 - * She proposes evaluating the offering St. James makes to the ELCA and regarding it at as a tithe rather than an amount that should be increased every year.
- Daniel Heiman noted that, relative to the prepayment of contributions, some members might have chosen to make this payment in January rather than December because of tax changes.
 Mike Bennett noted that some of the prepaid contributions had come in since the report had been published.
- Mark Taylor asked what the long-term plan was for funding the new position of Volunteer Coordinator. Pete Clemens noted that the hope was to be able to cover it within the personnel budget starting in 2014.
- Jon Paul noted that this was a very tight budget.

Detlef Koska asked for a motion to approve the 2013 budget. It was approved with 2 dissensions.

Pete Clemens reminded the congregation of the objectives that the Council had introduced a year ago. He explained that this year's Council had been working on ways to reach these goals, with particular emphasis on the objective to increase attendance and membership. One obstacle to attracting new members is the fact that the church is not easily visible from the road. He reviewed the actions being

taken to increase the visibility of the church; exterior lighting, new web site, buckthorn removal and demolition of the little house; as well as the funds that had been identified to pay for these actions. He showed a plat of the church property and explained where the buckthorn would be removed.

Comments/questions:

- Mike Bennett clarified that the large rectangle on the plat identified the church property while the area shaded in red identified the area where buckthorn would be cleared.
- Cobi Stein asked about the condition of the little house. Pete Clemens explained that the house was in very poor condition and was not able to be used any longer.
- Carole Tanner asked how the land would be maintained so that the buckthorn would not return. Pete Clemens explained that when the current plants were removed, the stumps would be treated so they would not grow back. Every year or two volunteers would be needed to cut down any new seedlings.
- Tom Ebert asked if there was a plan to provide further parking. Pete Clemens noted that
 while the City of Lake Forest would not let us put gravel on the lot where the house will be
 torn down, the area would be seeded with grass and would accommodate some over-flow
 parking.
- Jon Paul asked if there was any plan to do previously identified projects such as the improvements needed in the Sunday School area. Detlef Koska replied that these activities would likely be funded in the future through fund raising.
- Detlef Koska thanked Pete Clemens for all of the work he has done, particularly in working with the city of Lake Forest on the little house demolition and buckthorn removal projects.

Randy Daniel spoke about the position of the Volunteer Coordinator. This position was part of the objective to increase the congregation's participation in outreach opportunities, specifically to ask each member to be engaged in at least one activity each year. The person serving in this position would help people understand what the opportunities are and track the involvement in the various activities. Interested candidates will be interviewed and the job will begin August 1, 2013. Randy Daniel reviewed the job description.

Comments/questions:

• Carol Bennett noted that the church already owns the software *Servant Keeper*, which should be useful for tracking involvement in the outreach opportunities.

Detlef Koska noted that there were four volunteers for Synod Assembly Voting Members: himself, Pete Clemens, Linda Berner and Randy Daniel as an alternate. There were no volunteers from the floor and the four named were elected unanimously.

Detlef Koska thanked all of those who had been working on the budget process and the various other activities. He especially noted the office staff and members of the finance committee.

Joe Voelcker said that more volunteers were needed to count the offering after church services on Sundays. Anyone interested may contact him to volunteer.

The meeting was adjourned at 11:40 a.m.

Pastor Holmer offered thanks to all of those working to take action in needed areas and closed the meeting by leading the congregation in prayer.

Report of the President

The celebration of our 50th anniversary continued during the second half of 2012. On August 1, representatives of our Youth Group and a few adults headed by John Webster's gleaming red Ford Falcon pickup truck participated in the Lake Forest Day Parade handing out an invite to St. James Family Fun Fair, water and other goodies to by-standers. Later that month, Nathan Laube enthralled the audience with his brilliant organ play. One day before Rally Day, we invited community members to a Fabulous-Family-Fun-Fair with ice cream and games under a tent on the front lawn blessed by bright and warm sunshine. Also in September, we presented a gigantic check for \$100,000+ to Denver Bitner, CEO of LSSI, in a special service ceremony. Finally on Thanksgiving Day, we celebrated together with The Church of the Holy Spirit and First Presbyterian Church of Lake Forest in a very festive Thanksgiving service.

Earlier the Church Council formulated key objectives namely:

- 1. Increase membership involvement in outside services and mission work
- 2. Increase church attendance by 20%
- 3. Initiate a capital campaign within the next five years.

To fulfill at least some of these objectives the Church Council spent two days in October in a retreat and developed the following strategic actions:

- 1. Improve the Church's visibility
- 2. Upgrade the WEB site
- 3. Establish the position of a Volunteer Coordinator.

This resulted in specific projects which were:

- 1. The website was redesigned with the help of an outside consultant. Eric Holmer was selected and a significantly improved website is up and running.
- 2. New computers were installed replacing outdated equipment. Special thanks to Michael Beacham for facilitating the purchase and installation of the new computers and assisting in the development and maintenance of the new web site.
- 3. Buckthorn and little house were removed. Pete Clemens coordinated this effort together with the Property Committee and today the little house is finally removed and so is most of the buckthorn on the south side. With some generous financial support from neighbors, the buckthorn on the remaining property will be removed on the south and west side. What a spectacular improvement!
- 4. In May, an outside lighting test was conducted, which was very positive. Bright flood lights will be installed on the east and south side of the church which will greatly enhance its visibility at night.
- 5. From several candidates, Debbie MacAyeal was chosen as the new Volunteer Coordinator. Combined with her Christian Education responsibilities, her new title will be Director of Discipleship. Debbie will commence her duties in August. St. James functioning and success depends to a very large part on its volunteers. The number of volunteers who are enthusiastically serving is relatively small and we need more of them.

The Lily Foundation had awarded a grant to fund Pastor Holmer's well deserved sabbatical, which he started in mid-April with a journey to Israel. He is expected to return to us on August 4. In the meantime, Terry Dufur is providing pastoral coverage. All Church Council members are sharing numerous duties normally performed by Pastor Holmer such as opening and closing the Church on Sundays and making announcements. As of this writing things are working smoothly and harmoniously. Especially Pastor Dufur's lively sermons which are well received by the congregation, and we are thankful.

In October a team of "handy people" went to Biloxi and helped build houses organized by Habitat for Humanity. It's such a valuable program and was a wonderful experience for all who went. We have been supporting Habitat in Waukegan for quite some time, and there are numerous opportunities in upcoming weeks for volunteering. There are many jobs requiring various skills. Instructors are always helpful and patient. It's fun and rewarding to volunteer.

I traveled with my wife from August to November. During this time Pete Clemens took over my duties as Council President, and I am very thankful for this. During our journey, which took us through the Rocky Mountains, Canada, the Alaska Highway all the way to Fairbanks and later down the Pacific Coast, we admired God's creations in its many forms. We also attended different churches with quite small and some very large congregations. Several churches used large projection screens for readings and other texts we typically print in our bulletins. Some administrators pointed out very significant cost reductions by eliminating the paper copying. Just food for thought.

My term as Council President is ending, and I thank Pastor Holmer, Pastor Dufur, our staff, my fellow council members, the numerous committees and their chair persons and the congregation for their commitments, their help and actions to create the success St. James enjoys in the spirit of our mission. I am very grateful to be part of this group.



Report of the Worship and Music Committee

At worship each week, we confess our sins, receive forgiveness, hear the Word proclaimed, share communion and a blessing, and depart the church building with renewed strength to carry the light of Christ into the world. During the seasons of Advent and Lent, we have additional opportunities to be deliberate in our faith practices at mid-week Vespers services.

The church year begins with Advent – that beautiful season of anticipation. Christmas



(all 12 days) is followed by Epiphany. Ash Wednesday ushers in Lent, a period of contemplation culminating with the three-day services of Maundy Thursday, Good Friday and Easter Vigil. Easter is the highlight of the church year, and its season lasts until Pentecost. Pentecost Sunday celebrates the beginning of the church and the period after Pentecost is a long "green" season. As Lutherans, we celebrate Reformation Sunday in October. The church year ends with Christ the King Sunday, at the end of November.

It takes a team to organize and provide each and every worship service. A minimum of 12 servants (including the pastor) staffs each service, before counting musicians! Our music leaders are staff members, but the musicians themselves are your fellow congregation members, as are the assisting ministers, communion assistants, lectors, greeters, ushers, acolytes and altar guild. All of the senses are engaged – the visual symbols and furnishings, the spoken and musical messages, the touch of the greeting of peace, the taste and smell of the bread and wine.

The services are prepared with liturgy and music appropriate for the church season, our denomination, and the lessons from the Revised Common Lectionary, used by churches around the world. On any given Sunday, our worship is part of a worldwide activity where the basic structure of the service is similar and each congregation incorporates meaningful selections for its own family.

The committee is grateful for those who serve in the roles of worship servants and musicians. New faces are always welcome and training is always available.

The worship attendance graph tells a story of declining weekly worship attendance. This trend is not limited to our congregation or denomination. (When we have 8:30 and 10:45 services on a Sunday, about one third of attenders are at the earlier time and two-thirds worship later.) Weekly worship is a faith practice by which we help each other to remain strong. Our community is diminished by each absence and strengthened by each one present. Weekly attendance can be habit-forming!

Report of the Women of St. James

The Women of St. James is a community of women building relationships through faith enrichment, fellowship, social awareness and service. Here is a description of our activities this year:

Faith Enrichment

Our faith focus for the 2012-13 program year centered on the theme of Hope, developed and led by St. James members and began in October with "Conversations about Hope." We defined God's Hope and wrote messages of hope to members of the congregation. In April, thirty-five women participated in our 7th annual retreat in a one-day retreat at St. James that included two hours of service at Feed My Starving Children. Pastor Sheila (Anderson) Rawn presided over an Affirmation of Baptism. After a brief study of Paul, the Apostle of Hope, the women read one of four biographies on Martin Luther King, Jr., Corrie ten Boom, Martin Luther and Mother Teresa to understand how God's hope helped them maintain faith despite the struggles in their lives. In October, a group of St. James women attended the Women of Faith Conference in Milwaukee.

Fellowship

In July, a program was held following worship regarding the valuable oils found in the Bible. In August, members gathered at Independence Grove for a potluck supper and enjoyed an outdoor concert together. In December, we hosted the sixth annual "Holiday Sharing and Cookie Exchange." The bake sale the following day raised \$431 that was donated to ELCA Disaster Relief. In February, we held our sixth annual potluck dinner and examined how friends encourage hope in one another. The Women of St. James hosted receptions following summer worship and on Lessons and Carols Sunday.

Service/Outreach

The longest running service project for the Women of St. James is the sewing group. The group continues to make pillows, teddy bears and quilts for Lutheran World Relief and LSSI. "Notes from the Narthex" sessions were held inviting members of the congregation to participate in an "in-reach" by writing notes of encouragement and appreciation. Sunday School HVAC

The existing heating unit was replaced with a new furnace and with air conditioning in April.

Library Lighting:

New pendant lighting was installed in May.

Exterior Enhancements by Members:

Report of the Endowment Fund Committee

Members: Jim Davoux, Carol Bennett, Richard Falusy, Deb Moore, and Pastor Holmer (exofficio).

At this time last year the value of the endowment fund was at \$304,094 at the end of the first quarter. The good news is that the endowment fund value was up to \$307,644 (this is after the withdrawals in paragraph below) at the end of the first quarter this year. In 2008, prior to the recession and significant drop in the markets, the value was \$269,727. It is promising to see the value of the endowment fund return to and exceed historical levels. The endowment fund continues to use the services of the Blue Prairie Investment group. This group provides

investment services for a number of not-for-profit groups and continues to manage our investments with a long-term view and the goal of sustaining the endowment fund for the long term.

During the first quarter of 2013, \$8,100 was withdrawn from "Other Restricted Funds" for partial payment of the 2013 Buckthorn Removal Project. An additional \$13,816 was withdrawn from "Other Memorials" to fund the 2013 Exterior Lighting Project and 2013 Technology/Web site Project. All of these withdrawals were approved by Church Council.
